For all the above post, Knowledge of IT applications, virtual meeting platforms and computer skills (MS Word, Excel, PowerPoint, Tally, etc.) will be added advantage.

The application received will be shortlisted as per academic performance and assessment criteria. Shortlisted candidate(s) will be called for interview, if necessary written tests and assignments will also be conducted before the interview. At any stage if all the candidates who have same marks will be considered to have qualified for further rounds. Candidates having more than one qualification shall have to choose only one for selection process.

Young Professionals will be engaged initially for one year which shall be extendable for 2 more years subject to requirement of the services of the Young Professional in the organization and satisfactory performance of the candidate after evaluation before a committee. Maximum duration of the engagement of the Young Professional shall be 3 years.

**Age Limit:** Minimum of 21 years and a maximum of 45 years with relaxation as per rules.

**Emoluments:** Post will carry a consolidated emolument of Rs.35,000 per month, No HRA will be paid.

- The written test for the above position will be conducted through in- person at ICAR-Sugarcane Breeding Institute, Coimbatore (Scheduled date & time which will be intimated later on through phone /email / whatsapp or uploaded on the Institute website <https://sugarcane.icar.gov.in>)
- The candidates should bring a copy of bio-data (specimen enclosed), entire original certificates from SSLC onwards, one set of photocopies of certificates, experience certificate and latest passport size photograph at the time of written test.
