1. No. of Position : 1 (One)
  2. Duration : From the date of engagement to October 2025 or till winding up of the project whichever is earlier.
  3. Essential Qualifications : Graduation (B.Sc./B.Tech) in Life Sciences from recognized university with 3 years/4 years of bachelor degree.  
Specialization of life/basic sciences in Plant Molecular Biology / Plant Sciences / Bioinformatics / Biotechnology / Biochemistry / Microbiology / Botany.
  4. Desirable Qualifications : Experience in molecular biology / tissue culture
  5. Remuneration : Rs. 18,000/- per month (consolidated)
  6. Age : Minimum age is 21 years and maximum age will be 30 Years. The age limits are relaxable for SC, ST & OBC candidates as per Govt. of India norms.
1. The written test cum interview for the above position will be conducted through in- person at ICAR –SBI, Coimbatore on **13.08.2024 at 9.00 AM.**
  2. The candidates should bring bio-data (in prescribed proforma) entire original certificates from SSLC onwards, one set of photocopies of certificates (self-attested), experience certificate and latest passport size photograph at the time of written test for verification. **Candidates those who fail to submit original certificates for verification will not be allowed for written test.**
  3. The candidate should hold Degree certificate (at least Provisional certificate) in original in r/o. Graduation//Post graduation/Professional courses (website results/ Awaiting for results candidates will not be allowed/considered).
  4. No objection certificate from the employer, in case he / she is employed elsewhere.
  5. No TA/DA will be paid to any candidate to attend the Written test.

6. The above position is purely on temporary basis and is co-terminus with the project.
7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
8. **The selected candidate will be working on whole time basis and will not be allowed to register himself/herself for any academic programme etc.**
9. The candidates appearing for the written-test cum interview should follow Social Distancing inside the campus till the written test procedure gets completed.
10. The candidates should wear mask till the completion of written test procedure.
11. The written test cum interview will be conducted by strictly following COVID 19 guidelines given by Tamil Nadu state government / Government of India. All the candidates should follow the COVID 19 guidelines as such, any deviation is found, the candidate will not be allowed to attend the written test. No candidates will be allowed to enter ICAR-SBI campus without mask.

13. **All eligible candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for necessary formalities and verification of documents.**
14. Selected Candidates (s) will be required to produce all original documents(certificates) at the time of Joining for verification purpose.
15. The selected candidate will be required to produce medical certificate at the time of joining.
