NOTIFICATION

It is proposed to fill up one position of “**JUNIOR RESEARCH FELLOW**” on contractual basis under the DBT-NNP project entitled “**Development of Genome consortium Databank from plants and microbial population emerging from India**” by walk-in-written test-cum-Interview at ICAR-Sugarcane Breeding Institute, Coimbatore-7 (Tamilnadu) on **9.08.2024 at 9.00 AM.**

JUNIOR RESEARCH FELLOW

1. No. of Position : 1 (One)
2. Duration : Five years or till winding up of the project whichever is earlier.
3. Essential Qualifications : Master degree in relevant subject with 4years/5 years of Bachelor's Degree.
Candidates having Post-graduate degree in Life Sciences with **3 years Bachelor's degree and 2 years Master's degree should have NET qualifications** {CSIR-UGC NET/ASRB-NET/GATE or selection through any Central Government Departments and their Agencies and Institutions such as DST,DBT,DAE, DOS, DRDO, MHRD, ICAR, ICMR, IIT, IISC, IISER etc. }.
4. Desirable Qualifications : Preferably with **Specialization in Biotechnology / Biochemistry/ Bioinformatics / Molecular Biology**
5. Remuneration : Rs. 31,000/- + 20%HRA per month
6. Age : The upper age limits are 30 Years for Men & 35 Years for Women. The age limits are relaxable for SC, ST & OBC candidates as per Govt. of India norms.

1. The **written test cum interview** for the above position will be conducted through **in- person at ICAR –SBI, Coimbatore on 9.8.2024 at 9.00 AM.**
2. The candidates should bring bio-data (in prescribed proforma) entire original certificates from SSLC onwards, one set of photocopies of certificates(self attested), experience certificate and latest passport size photograph at the time of written test for verification. **Candidates those who fail to submit original certificates for verification will not be allowed for written test .**

3. The candidate should hold **Degree certificate (atleast Provisional certificate) in original in r/o. Graduation//Post graduation/Professional courses**(website results/Awaiting for results candidates will not be allowed/considered).
4. No objection certificate from the employer, incase he / she is employed else where.
5. No TA/DA will be paid to any candidate to attend the Written test.
6. The above position is purely on temporary basis and is co-terminus with the project.
7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
8. **The selected candidate will be working on whole time basis. He/She will be allowed to register Ph.D. as per ICAR guidelines only with a recognized University by UGC/ICAR-AU system. The student and guide/PI of the scheme must follow the rules and regulations of the Institute as well as the University where the student has registered with.**
9. The candidates appearing for the written-test cum interview **should follow Social Distancing** inside the campus till the written test procedure gets completed.
10. The candidates **should wear mask** till the completion of written test procedure.
11. **The written test cum interview will be conducted by strictly following COVID 19 guidelines given by Tamil Nadu state government / Government of India. All the candidates should follow the COVID 19 guidelines as such, any deviation is found, the candidate will not be allowed to attend the written test. No candidates will be allowed to enter ICAR-SBI campus without mask.**
12. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
13. **All eligible candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for necessary formalities and verification of documents.**
14. Selected Candidates (s) will be required to produce all original documents(certificates) at the time of Joining for verification purpose.
15. The selected candidate will be required to produce medical certificate at the time of joining.
16. The decision of the Director, ICAR-SBI, Coimbatore will be final and binding on all aspects. The Director shall also reserve the right to terminate the contract of job as mentioned above, even before the completion of the project/contract period for which no appeal thereof shall be made.
17. The Director, ICAR-SBI, Cbe-7 reserves the right to cancel/postpone the scheduled written test cum interview without assigning any reason thereof.
18. In case of any dispute, it will be resolved in jurisdictions of Coimbatore court only.
