- 1. Only the 'Fellows of SSRD' are eligible for the award.
- 2. One SSRD Fellow with the highest scoring will be chosen for the award, except in the first year.
- 3. The Fellow of SSRD applying for this award should have made substantial contributions in the field of either research or development in sugarcane or sugar industry for a minimum period of 15 years.
- 4. A Fellow of SSRD may apply for this award, 5 times during his lifetime.
- 5. The award will be named as "Best Researcher Award" in case of R & D personnel or "Best Achiever Award" in case of industry personnel.
- The recognition of members for this award will be discussed and finalized in the Executive Council. The decision of the EC will be announced in the annual General Body meeting of the Society.
- 7. The cut-off mark for this award is 70.
- 8. Proforma with incomplete information is liable for rejection. No communication will be made in this regard.
- 9. Proofs for claims made in the applications should be attached.
- 10. While quoting your publications, please consult the catalogue of journals with NAAS scores and list only those publications that have been published in NAAS rated journals. *Please avoid publication in non-refereed journals and do not list papers from the proceedings/ abstracts presented in workshops/ symposia.*
- 11. Members / Applicant can't claim the award as matter of their rights.
- 12. The President of SSRD in consultation with the Executive Council reserves all rights to accept or reject the application(s).
- 13. Last date for submission of Nomination form is on or before 5.30 PM of 21st Oct 2024.
- 14. No updates/ additional information shall be considered after the due date.
- 15. Duly completed Nomination Form should reach the General Secretary, Society for Sugarcane Research and Development (SSRD), ICAR-Sugarcane Breeding Institute & PO, Coimbatore-641007 on or before the due date.
