Before sending the nomination, please read the followings:-

1. Please check the Guidelines for Evaluation or contact the General Secretary, SSRD, Coimbatore (Email: ssrd.coimbatore@gmail.com)
2. This award will be presented to young members of SSRD to encourage their scientific talent, creativity as reflected through their contribution in the field of sugarcane research and development.
3. Any member of SSRD who have a continuous standing for FIVE years in the Society and NOT ATTAINED THE AGE OF 40 YEARS ON 31ST AUGUST of the year in which the award was announced, are eligible for the award.
4. The number of awards to be made in any year will be limited to ONE.
5. In the first three years from 2020, a candidate for the award may be proposed by “Life Member” of SSRD. Afterwards a candidate shall be nominated by “Fellow” of SSRD, or by earlier recipients of this award. Self-nomination will not be considered.
6. A nomination will remain valid for consideration by the Society for 2 years or the eligibility age whichever expires earlier. The candidate who wish to make his nomination for the second year may send a message to the Society along with updates etc if available but no need to send nomination form again.
7. The names of the Young Scientists selected for the award will be announced in annual General body meeting of the Society or similar such meeting.
8. The award shall consist of a Bronze Medal and a Certificate. All members of the Society having a continuous standing for five years are eligible to be considered for the Young Researcher Award of the Society.
9. A Proposer can nominate maximum for TWO awards in a year.
10. The cut-off marks for the deciding the eligibility for the award is 60.0 (SIXTY)
11. All the valid nominations will be discussed and finalized in the Executive Council. The decision of the EC will be announced in the annual General Body meeting of the Society.
12. Proforma with incomplete information is liable for rejection. No communication will be made in this regard.
13. Members can't claim the award as matter of their rights. The President of SSRD in consultation with the Executive Council reserves all rights to accept or reject the applications.
14. Duly completed nomination Form should be sent by Post, Courier or by Hand, to Secretary, Society for Sugarcane Research and Development (SSRD), ICAR-Sugarcane Breeding Institute, Coimbatore, Tamil Nadu-641007 on or before **21st Oct 2024**.
