 The period of Auction / Sale will be for 1 year with effect from the date of receipt of the offer letter. Therefore, the bidders are requested to bid or offer the rate after inspecting the fruits of tamarind trees at ICAR-Sugarcane Breeding Institute, Coimbatore and satisfying the quality of product.

- 2. The bidders who wish to participate in the auction shall be present on the auction spot half an hour before the start of auction so as to pay the bid security. If there is any sort of hartal, etc on the notified date, the auction will be conducted on later date notified by the offic
- 3. The bidders are requested to deposit a sum of Rs.2,000/- (Rupees two thousand only) to the office as bid security. No person will be allowed to bid in the auction unless he / she remit the bid security amount before the commencement of auction time mentioned in the notice. No post auction will be entertained.
- 4. The bid security amount of the unsuccessful bidders will be returned immediately after the close of auction. The bid security of successful bidder will be retained by the office and will be adjusted towards the declared bid amount due from him/her.
- 5. The bidder who bid or offered the highest rate in the auction will be declared as successful bidder.
- 6. The successful bidder should pay the full amount declared in the auction within a day, either by swipe machine country online payment to our office account or by D.D. drawn in favour of the Director, ICAR-Sugarcane Breeding Institute, payable at State Bank of India, Veerakeralam Branch (Code 10618), Coimbatore, Tamil Nadu.
- 7. In case of successful bidder fails to pay the full bid amount within a day after conclusion of auction, the bid security amount deposited by him/her will be forfeited to the ICAR and the above items will be re-auctioned at his/her risk and cost.
- 8. The finalization of auction is subject to confirmation by the Director, ICAR-Sugarcane Breeding Institute, Coimbatore-641007.
- The successful bidder should execute an agreement to the Director, ICAR-Sugarcane Breeding Institute, Coimbatore in the form which will be supplied to him / her within 5 days of receipt of work order.

The successful bidder may collect fruits during the prixing hours (9.00 AM to 5.30 PM) of the Institute after obtaining prior information from the Officer In-Charge (Farm) at his own cost from the specified trees, as is where is basis, for a period of 1 year i.e., with effect from the offer letter. The successful bidder will not be allowed to take or harvest beyond the period and to make claim of any other parts of the trees such as leaves, branches, etc.
- 11. It is the sole responsibility of the successful bidder to safeguard the produce as soon as he / she gets order from the office. The Institute or its staff will not be responsible for loss / damage to the coconuts during the tender period by natural calamities, enemy action, pests and diseases or any other means which are not within the control of the Institute.
- 12. The Director, ICAR-Sugarcane Breeding Institute, Coimbatore shall reserve the rights to accept or reject any bid / tender without assigning any reasons and to cancel the auction at any time in case of violation of terms and conditions.
- 13. The decision of the Director, ICAR-Sugarcane Breeding Institute, Coimbatore (TN) shall be final, in all issues related to the auction.
