- Essential : Post graduation(M.Sc/M. Tech) in Life Sciences from recognized university with 4 years/5 years of bachelor's degree and 2 years master's degree.

Masters degree in life/basic science with 3 years bachelor's and 2 years master's degree having qualified any one of National level examinations conducted by Central Government Departments and their Agencies and Institutions such as DST,DBT,DAE,DOS,DRDO,MHRD,ICAR, ICMR,IIT,IISC, IISER etc. with two years research experience.

- 5. Remuneration : Rs. 42,000/- (consolidated) per month
- Age
 35 Years for Men & 40 Years for Women. The age limits are relaxable for SC, ST & OBC candidates as per Govt. of India norms.
 - The written test cum interview for the above position will be conducted through in- person at ICAR -SBI, Coimbatore on 15.10.2024 at 9.00 AM.
 - The candidates should bring bio-data (in prescribed proforma) entire original certificates
 from SSLC onwards, one set of photocopies of certificates(self attested), experience
 certificate and latest passport size photograph at the time of written test for
 verification. Candidates those who fail to submit original certificates for verification will
 not be allowed for written test.

- The candidate should hold Degree certificate (atleast Provisional certificate) in original in r/o. Graduation//Post graduation/Professional courses(website results/Awaiting for results candidates will not be allowed/considered).
- 4. No objection certificate from the employer, incase he / she is employed else where.
- 5. No TA/DA will be paid to any candidate to attend the Written test.
- 6. The above position is purely on temporary basis and is co-terminus with the project.
- There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
- 8. The selected candidate will be working on whole time basis. He /She will be allowed to register Ph.D. as per ICAR guidelines only with a recognized University by UGC/ICAR-AU system. The student and guide/PI of the scheme must follow the rules and regulations of the Institute as well as the University where the student has registered with.
- 9. The written test cum interview will be conducted by strictly following COVID 19 guidelines given by Tamil Nadu state government / Government of India. All the candidates should follow the COVID 19 guidelines as such, any deviation is found, the candidate will not be allowed to attend the written test. No candidates will be allowed to enter ICAR-SBI campus without mask.
