- 1. The written test cum interview for the above position will be conducted through in- person at ICAR SBI, Coimbatore on 13.01.2025 at 9.00 AM.
- 2. The candidates should bring bio-data (in prescribed proforma) entire original certificates from SSLC onwards, one set of photocopies of certificates (self-attested), experience certificate and latest passport size photograph at the time of written test for verification. Candidates those who fail to submit original certificates for verification will not be allowed for written test.
- 3. The candidate should **hold Degree certificate** (at least Provisional certificate) in original in r/o. **Graduation//Post graduation/Professional courses** (website results/ Awaiting for results candidates will not be allowed/considered).
- 4. No objection certificate from the employer, in case he / she is employed elsewhere.
- 5. No TA/DA will be paid to any candidate to attend the Written test.
- 6. The above position is purely on temporary basis and is co-terminus with the project.
- 7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
