It is proposed to dispose of the fruits and nuts in **175 Cashew trees** grown at ICAR-Sugarcane Breeding Institute -Research Centre, Agali-678581, Kottathara PO, Mannarkad Taluk, Palakkad Dist. (Kerala) through **Public Auction**. The auction will be conducted at ICAR-Sugarcane Breeding Institute-Research Centre, Agali on **21.03.2025 (Friday)** at **11.30 A.M.** Interested party /bidders may inspect the Cashew trees during the working hours of the Research Centre after obtaining prior permission from the Scientist in-charge of the Centre. Terms and Conditions

1. The period of Auction / Sale will be for **3 months i.e., from April to June 2025**. Therefore, the bidders are requested to bid for or offer the rate for all the nuts that are presently found in 175 Cashew trees as well as the fruits and nuts expected during the tender period, after inspecting the fruits and nuts bearing trees and satisfying the quality of fruits and nuts.
2. The bidders who wish to participate in the auction shall be present on the auction spot half an hour before the start of auction so as to pay the bid security. If there is any sort of hartal, etc on the notified date, the auction will be conducted on later date notified by the office.
3. The bidders are requested to deposit a sum of **Rs.5000/- (Rupees five thousand only)** to the office as **bid security**. No person will be allowed to bid in the auction unless he / she remit the bid security amount before the commencement of auction time mentioned in the notice. No post auction will be entertained.
4. The bid security amount of the unsuccessful bidders will be returned immediately after the close of auction. The bid security of successful bidder will be retained by the office and will be adjusted towards the declared bid amount due from him/her.
5. The bidder who bid or offered the **highest rate in the auction will be declared as successful bidder**.
6. The **successful bidder should pay the full amount declared in the auction within 3 days**, either by swipe machine or by online payment to our office account (A/C No.10663184080 A/c Name: ICAR-SBI, IFSC Code-SBIN0010618 or by D.D. drawn in favour of the the Director, ICAR-Sugarcane Breeding Institute, payable at State Bank of India, Veerakeralam Branch (Code 10618), Coimbatore, Tamil Nadu.
7. In case of successful bidder fails to pay the full bid amount within 3 days after conclusion of auction, the bid security amount deposited by him/her will be forfeited to the ICAR and the above items will be re-auctioned at his/her risk and cost.
8. The finalization of auction is subject to confirmation by the Director, ICAR-Sugarcane Breeding Institute, Coimbatore-641007.
9. The successful bidder should execute an agreement to the Director, ICAR-Sugarcane Breeding Institute, Coimbatore in the form which will be supplied to him / her within 5 days of intimation of confirmation of auction or before the collection of ripe coconuts, whichever is earlier.
10. The successful bidder may collect or harvest the coconuts at his own cost from the 175 Cashew trees, as is where is basis, for a period of **3 months i.e. from April to June 2025**. Only fruits and nuts in the trees are sold to the bidder. The successful bidder will not be allowed to take or harvest or to make claim of any other parts of the trees such as leaves, branches, young inflorescence, etc.
11. The successful bidder is allowed to harvest the fruits and nuts between 9.00 AM to 5.30 PM on working days and after getting the confirmation order from the office and after intimation to the Scientist in-charge of the Centre.
12. No damage to the trees shall be caused while harvesting fruits and nuts.

Any loss or damage, etc. caused by the bidder to the trees or any institute properties will be recovered from him/her.

13. It is the sole responsibility of the successful bidder to safeguard the fruits and nuts as soon as he / she gets order from the office. The Institute or its staffs will not be responsible for loss / damage to the ripe coconuts during the tender period by natural calamities, enemy action, pests and diseases or any other means which are not within the control of the Institute.
14. The Director, ICAR-Sugarcane Breeding Institute, Coimbatore(TN) shall reserve the rights to accept or reject any bid / tender without assigning any reasons and to cancel the auction at any time in case of violation of terms and conditions.
15. The decision of the Director, ICAR-Sugarcane Breeding Institute, Coimbatore (TN) shall be final, in all issues related to the auction.
16. Disputes, if any, will subject to the jurisdiction as decided by the competent authority of the ICAR-SBI, Coimbatore (TN).
